## ASIB LISTING CONFIRMATION

Regrettably ASIB will not be issuing any further letters confirming a company's listing or listing status.

The decision is due to, but not necessarily limited to, the following:

- Letters not issued by our company indicating unlisted companies are listed with the ASIB
- Listed companies using outdated registration letters which can indicate that the company had a higher listing status than their current listing
- Third parties who have fraudulently manipulated the registration letter to indicate that they are approved with the ASIB as fitters or welders etc.
- Suppliers using the ASIB confirmation of registration to act as an Installer and Installers using the letter to act as Suppliers
- Registration letters are used by Installers not listed as Special Risk Installers to quote on Special Risk Installations and Special Risk only Installers using their listing to quote on Sprinkler Installations

The ASIB website is kept up to date with a full and comprehensive list of the installers, their current level of listing and what they are listed as.

It also provides a detailed explanation on the ASIB's levels of listing to enable the end user to make an informed decision on the installer or supplier capabilities.
